New winter shirt/cap order being discussed – can have different designs for each Match type.

**New Business:** Discussed question of refund for temporary members that don't complete membership requirements within the 90-day probation period – no refund. Approved \$150 for "smart thermostat" programmable temps during the day/night and monitor and change setting remotely thru Wi-Fi. Discussed a safety fence between Field 1 and the Wobble Trap and will put up signage to prohibit Wobble shooting during Field 1 shooting and vice versa. November Election, to determine if there's any seats to be filled? Will send notice October 1<sup>st</sup> for the 2025 Membership drive and schedule envelope stuffing session. Neal has set up two address options for 911 calls – 1995-A Goldston Springs Road is the Clubhouse and main Club area while 1195-B designates the 600-yard entrance. These address signs will be installed at both entrances and will start to educate membership about using these addresses for any 911 call. To get quotes to have front driveway asphalt sealed from weathering. \$150 approved for additional folding chairs for various places around the Club. To schedule work day to run electrical from Skeet Field #1 to the Wobble. To get quotes for increasing the parking space at the 600-yard range. To look into and get quote on a utility vehicle to be used on the grounds.
